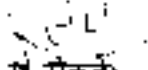

7. Other provisions

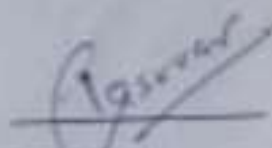
- 7.1 The Contractor shall carry out project accounting in keeping with the principles of proper bookkeeping.
