





WHEREAS.

Both SVERI and NHAI are desirous of working together with mutual cooperation for dissemination of respective expertise in civil/highway engineering field through the road infrastructure development.

NOW. THEREFORE, IT IS HEREBY AGREED BY THE PARTIES AS FOLLOWS:

#### 1. INTENT:

National Highways Authority of India (NHAI) intends to associate the SVERI who shall voluntarily contribute its share of experience for betterment of the highway infrastructure.

#### 2. SCOPE OF THE MoU

The primary scope of MOU inter alia includes the following:

- (v) NHAI shall pay stipend @ Rs. 8000 (Rupees Eight Thousand only) per month for undergraduate students and @ Rs. 15000 (Rupees Fifteen Thousand only) per month to Postgraduate students. All other arrangements including stay shall be responsibility of the Institute. However, depending upon availability, NHAI may extend transportation facility to the interns within the project jurisdiction.



And

Tata Technologies Limited (hereinafter referred to as "Tata Technologies") is a company registered under the Indian Companies Act, 1956 and has among other businesses, in the business of providing products and services to OEM and Engineering Sectors in the area of Automotive and Aerospace, having its registered office at 25, Rajiv Gandhi Infotech Park, Pune – 411 057.

In the course of this MOU both parties to the MOU mentioned above have been individually referred to as "Party" and jointly as "Parties".

#### Objective and Terms

- 1. Tata Technologies under aegis of the Corporate Sustainability Program (CSP) has identified the need for imparting quality training in the "Design Engineering" domain to 3rd and 4th year Mechanical Engineering Students of SCEP. The main intent behind this initiative is to better equip young engineers to increase awareness and industry connect. The Parties intend to enter in to this MOU to provide a frame work evaluating the area of collaboration between them and establish certain rights and obligations between the Parties during such evaluation. Tata Technologies plans to roll out this e-learning program as a pilot project in SCEP.
- 2. This MOU further establishes an understanding between the Parties to do a pilot test for conducting a Design Engineering training for 3rd & 4th year Mechanical Engineering students ("Students") of SCEP using methods and aids generally associated with distance learning. This training is being planned for the first time by Tata Technologies and is currently being conceptualised by Tata Technologies' employees who are experienced in Design Engineering. - C) The Parties intent to cooperate and focus their efforts on cooperation within area of Empowerment Programs through Skill Based Training, Strategic Consultation, Education and Research.




